ABOUT THE THREE-WAY COVENANT

The United Church of Christ advises that, when an Authorized Minister is called to serve a Local Church, a covenantal relationship be established among the Authorized Minister, the Local Church, and the United Church of Christ as represented by an Association or Conference. This relationship is known as a three-way covenant, with each party accountable to and for the others. The purpose of this covenant is three-fold:

- 1. to strengthen, support and sustain the ministries of all the partners that share in this covenant;
- 2. to encourage mutual participation and accountability of and for the life of each by the others;
- 3. to observe, nurture, celebrate, and call forth the ministry of the Authorized Minister.

COVENANTS OF MUTUAL ACCOUNTABILITY

Authorized Minister, as an Authorized Minister of the United Church of Christ covenants:

To <u>Local Church</u> United Church of Christ in <u>City/State</u>:

- Faithful preaching and teaching of the Gospel, the exercise of pastoral functions, and the administration of rites and sacraments of the Church as such time and in such places as may be appropriate;
- Membership in good standing with <u>Local Church</u>, including financial support for the general ministries of this church and a commitment to earnest prayer for the well-being of this congregation and its ministry; public recognition of membership in this Body of Christ;
- Regular meetings with the Church Council and Pastoral Relations Committee to support one another in mutual ministry;
- Fidelity to the terms of her/his call agreement (attached) and dedication to the tasks as set forth by his/her job description (attached), so long as Authorized Minister serves as Title and Position of Local Church. Obligations of compensation and employment exist exclusively between Authorized Minister and Local Church.

To the Association/Conference:

• Participation in Association Annual Meetings, Ministerium gatherings, Conference Annual Meetings;

• Adherence to oversight by the Association Committee on Ministry, including the annual Information Review and the triennial Periodic Review.

Local Church United Church of Christ, as the Local Church of Membership covenants:

To Authorized Minister:

- Belief in God's call that has led you to this particular place of mission and ministry
- Adherence to remuneration as set forth in the call agreement and job description;
- Prayers for her/his work with the Local Church;
- Public recognition of <u>Authorized Minister</u> a Minister of the congregation;
- Regular meetings with the Church Council and Pastoral Relations Committee to support one another in mutual ministry.

To the Association/Conference

- Appropriate documentation of <u>Authorized Minister</u> as an Authorized Minister with ministerial standing;
- Fidelity to the covenants of mutual accountability as articulated in this document.

A FOUR-WAY MINISTRY COVENANT AMONG

AUTHORIZED MINISTER CALLING BODY / EMPLOYER LOCAL CHURCH ASSOCIATION / CONFERENCE

ABOUT THE FOUR-WAY COVENANT

The United Church of Christ advises that, in instances where Ordained Ministers are called to non-parish employment, a covenantal relationship be established among the Ordained Minister, the calling body, the United Church of Christ as represented by an Association or Conference, and the Local Church where the Ordained Minister is a member. This relationship is known as a four-way covenant. The purpose of this covenant is:

- 4. to strengthen, support and sustain the ministries of all the partners that share in this covenant;
- 5. to encourage mutual participation and accountability of and for the life of each by the others;
- 6. to observe, nurture, celebrate and call forth the ministry of the Ordained Minister.

COVENANTS OF MUTUAL ACCOUNTABILITY

Ordained Minister, as an Authorized Minister of the United Church of Christ covenants:

To <u>Local Church</u> United Church of Christ in <u>City/State</u>:

- Membership in good standing with <u>Local Church</u>, including financial support for the general ministries of this church, participation in the worshiping life of the church whenever possible, and a commitment to earnest prayer for the well-being of this congregation and its ministry;
- Submission of articles for the newsletter or other publications regarding his/her ministry;
- An annual meeting with the Church Council or other representative to support one another in mutual ministry;
- A commitment to preach annually at the request of the pastor;
- Public recognition of membership in this Body of Christ in duties related to her/his ministry.

To the Association/Conference:

• Participation in Association Annual Meetings, Ministerium gatherings, Conference Annual Meetings and other events whenever possible;

• Adherence to Oversight by the Association Committee on Ministry, including the annual Information Review and the triennial Periodic Review.

To the <u>Calling Body/Employer</u>:

- Faithful preaching and teaching of the Gospel, the exercise of pastoral functions, and the administration of rites and sacraments of the Church as such time and in such places as may be appropriate;
- Fidelity to the terms of her/his ministry and fidelity to the tasks of her/his employment, as given in her/his job description from the Calling Body/Employer (attached), so long as Authorized Minister serves as Title and Position with Calling Body/Employer. Obligations of compensation and employment exist exclusively between Authorized Minister and the Calling Body/Employer.

Local Church United Church of Christ, as the Local Church of Membership covenants:

To Authorized Minister:

- Prayers for her/his work with the Calling Body/Employer;
- Inclusion of materials written by <u>Authorized Minister</u> in the congregation's newsletter and Annual Report;
- Public recognition of Authorized Minister as a Minister in Mission of the congregation;
- An annual meeting with the Church Council or other representative to support one another in mutual ministry.

To the <u>Calling Body/Employer</u>:

• Collection of an offering contributing to the work of the Calling Body or a similarly related ministry.

To the Association/Conference

- Appropriate documentation of <u>Authorized Minister</u> as an Authorized Minister with ordained ministerial standing;
- Annual contributions to Our Church's Wider Mission (OCWM) in recognition of the role of the wider church in the formation and oversight of authorized ministers in the United Church of Christ.

The Association of the United Church of Christ covenants:

To Authorized Minister:

- All of the rights and responsibilities of an ordained minister in this Association.
- Clear communication of this Association's/Conference's requirements for good ministerial standing (including but not limited to boundary training and continuing education) and of any policies and procedures supplemental to the Manual on Ministry that have been established by this Association/Conference.
- Clear communication of this Association's/Conference's requirements for good ministerial standing (including but not limited to boundary training and continuing
